Bidders are advised to review this requirement with the suppliers of their acoustical storm windows to be certain that all of their storm windows will comply, and that storm windows that need sash assist balances to achieve compliance must be equipped with these devices.

The Piedmont Triad Airport Authority will receive bids for Phase 7 of its Residential Sound Insulation Program in the Stanley Frank Board Room at the Piedmont Triad International Airport until **10:00 a.m. on March 25, 2019**, at which time and place the bids will be opened and read aloud.
