## Spirit Airlines Official Rules Annual Princess Night with Grasshoppers

- **3. How to Enter:** Entrants are required to submit a first and last name, and valid email address and phone number. An entry will not be eligible to win a prize if the entrant does not have a valid e-mail address. Entries will be taken from July 5 to July 9, 2021.

<u>Limit</u>: Each participant may submit a total of one (1) contest entry. Any additional entries requested in excess of this amount will not be included in the drawing pool.

**4. Winner Selection:** One (1) potential winner will be chosen at random from among all eligible entries on Friday, July 9, 2021. The winner does not have to be present to win. The winner will be contacted via phone or email within 7 days following the winner being picked.
